MINUTES

1 Welcome and Apologies

The Chair welcomed attendees to the meeting and delivered an Acknowledgement of Country. No apologies were received.

2 Procedural Matters

3 Campus Committee Elections - Amendment to SULS Bylaws

Ben explained that the SULS Bylaws currently required Campus Committee Elections to be held during Semester One and that it was necessary to amend the Bylaws in order to hold elections for all cohorts, except the incoming LLBI and JDI cohorts, prior to the commencement of Semester One. Ben further explained that he needed the Campus Committee to help him organise events that would be held during Welcome Week and the beginning of Semester One, which is why this amendment was being pursued.

Ben read out the current wording of clause 10 of the Bylaws:

“10. Election Notices shall be issued in Semester One by the Campus Director, outlining:

a) That nominations for Campus Committee elections have opened; and

b) The time, date and place for close of nominations.”

Ben then read out the proposed amendment to clause 10 of the Bylaws:

“10. The Election Notices for the incoming LLBI and JDI cohorts must be issued in Semester



One. All other Election Notices shall be issued at the discretion of the Campus Director. When issued, all Election Notices must outline:

- a) That nominations for Campus Committee elections have opened; and*
- b) The time, date and place for close of nominations.”*
