### 5 Headspace subscription for SULLS members

Sofia noted that she and Calvin reached out to Headspace regarding quotes for a program. She noted that 99 people have expressed interest so far. Several clarifying questions were asked by Executive members.

Eden asked what the sign-up process would work, specifically whether it would be first come first serve or if there was another sign-up method. Sofia noted that it would be first come first serve at the beginning and we could re-evaluate the number of subscriptions we purchased, although she would have to check as to how that would affect the terms of the membership.

Wendy noted that accessibility is paramount, and also asked if it was possible to do a six month subscription rather than a 12 month subscription to double the amount of people SULLS could provide and also to allow the next SULLS Executive to re-evaluate if it was a program they wished to continue.



Georgia asked if there was a method to limit usage to SULLS members. Calvin suggested that we could require students to sign up with a university email address. He asked if SULLS had membership lists that could be cross-checked. Alison mentioned that we do have lists of members from November 2019 onwards, Other ideas were canvassed, including whether it was possible to generate unique codes for each member.
